



## About This Warranty

This warranty is provided by International Mowers Pty Ltd (ABN 58 628 705 475), the manufacturer and distributor of Atom Power Equipment in Australia. International Mowers Pty Ltd fulfils all warranty obligations under Australian Consumer Law and the New Zealand Consumer Guarantees Act, 1993. This warranty covers products sold only in Australia and New Zealand.

## Atom Warranty

Our products come with guarantees that are protected under Australian Consumer Law and the New Zealand Consumer Guarantees Act 1993. Customers have the right to a replacement or refund in cases of major failure and may request repairs if goods do not meet acceptable quality standards and the issue is not considered major. The Atom Warranty is provided in addition to any statutory conditions and warranties required by applicable laws in Australia and New Zealand.

Under this warranty, Atom products are covered from the original purchase date for the period specified below. Coverage includes mechanical defects and faulty workmanship or materials, entitling customers to factory-assembled part replacements, repair, or replacement of components due to manufacturing faults. Where relevant, defective parts will be serviced or replaced by an Authorised Service Dealer at no cost to the customer for labour or materials. Repairs or adjustments necessary because of normal wear and tear, or due to failure to follow instructions in the manual, remain the responsibility of the operator.

## Limitations of Warranty

Warranty coverage only extends to the original purchaser, who must provide proof of purchase (original sales docket) before any warranty work begins.

- Using non-genuine Atom parts voids the warranty.
- Professional use of domestic machines voids the warranty.
- No warranty applies if goods are not assembled and pre-serviced by a servicing dealer, regardless of whether purchased online or directly from a dealer. Purchases made "in a box" are not warranted.

## Domestic Use

The domestic warranty covers private, non-income-generating use at a single property, specifically at the residence of the product's owner. If the product is used at more than one property, it is considered commercial use, and the residential warranty does not apply. International Mowers Pty Ltd reserves the right to refuse or void the warranty if it determines the product has been used commercially.

## Professional Use

For this warranty, "professional use" includes any operation of the product by a business or individual for professional landscaping or gardening services, such as use by lawn care companies, council workers, or contractors maintaining multiple properties for profit. It also covers high-frequency or heavy-duty operation exceeding typical residential use, rental or hiring out of the product for profit, use by government or public institutions for maintenance of large spaces, and use on farms or commercial estates. Any scenarios described here are considered commercial use for warranty purposes.

## Atom Warranty Service

Warranty service is provided by Atom Authorised Service Dealers, who offer expert support. Warranty claims must follow the directions below. Only products delivered serviced and assembled by an Atom dealer are eligible for warranty. Regular maintenance per the manual is required to keep coverage. Warranty may be voided if non-authorised dealers perform repairs, non-genuine parts or unapproved attachments are used, or the equipment is modified.

## Lawn Edger Warranty

The warranty does not cover damage caused by excessive overheating of the clutch if the operator fails to follow operational instructions - specifically, not keeping the blades spinning rapidly at full throttle, or allowing the blades to dig deeper than 10-15 mm due to incorrect wheel height adjustment. Such misuse causes clutch slippage and overheating, which voids coverage. Additionally, blades on lawn edgers are not covered by the warranty.

## Garden Tiller Warranty

The warranty excludes gearbox damage or issues that result from failing to add grease every five hours, as outlined in the operator manual.

## Engine Warranty

Engines supplied with Atom machines are covered by warranties provided separately by their respective manufacturers. For the most up-to-date warranty terms and information on how to make a claim for these components, please refer directly to the relevant manufacturer's website.

## Important Notice for Australian Customers

Australian consumers are protected by the Australian Consumer Law (ACL). All goods include guarantees that cannot be excluded under the ACL. If a major failure occurs, you are entitled to a replacement or refund, as well as compensation for any other reasonably foreseeable loss or damage. If goods fail to meet acceptable quality standards but the failure is not major, you are entitled to have the goods repaired or replaced. This warranty operates in addition to, and does not exclude, restrict, or modify, any rights or remedies you may have under the Australian Consumer Law.

## How to Make a Warranty Claim

- First, contact your authorised Atom dealer.
- Be prepared to provide proof of purchase.
- Permit inspection of the equipment.
- Unless otherwise agreed in writing, you are responsible for freight costs.

**General Atom Powered Equipment Warranty Exclusions**

- Use of non-genuine Atom spare parts (such as edger blades) or any problems resulting from their use will void the warranty.
- Any alteration of the product also cancels the warranty.
- The warranty does not apply if Atom petrol products are run with incorrect fuel, oil, or oil levels.
- Failure to properly service the cooling or air filtration system voids the warranty.
- Not following the instruction manual, tags, or labels attached to the product cancels the warranty.
- Damage from accidents, misuse, neglect, dropping the unit, or dropping objects on the unit is not covered.
- Blades, filters, and spark plugs are considered consumable and are not covered by the warranty.
- Normal wear and tear, as well as fair wear and tear, are not covered. Engines and mechanical components require periodic service and parts replacement; warranty does not cover repairs when parts have reached the end of their normal lifespan.
- Warranty is void if the engine or machine is damaged due to misuse, lack of routine maintenance, improper handling, shipping, warehousing, or installation. Similarly, removing the serial number or using contaminated or incorrect oil invalidates warranty coverage.

- For four-stroke engines, users must check, and refill oil as needed and change it at recommended intervals; two-stroke engines must use the specified fuel/oil ratio as per the manual. Fuel spillage causing blocked air filters is not covered.
- The warranty does not cover repair or adjustment of parts such as throttle cables and switches.
- Damage or wear caused by dirt entering the engine due to improper air cleaner maintenance, incorrect reassembly, or use of non-original air cleaner elements is excluded. Clean and/or replace filters as stated in the Operator's Manual.

**Additional Exclusions**

The following are not covered by the warranty:

- Leaking carburetors, clogged fuel pipes, sticking valves, or other damage from contaminated or stale fuel/oil.
- Parts that are scored or broken due to operation with insufficient lubrication or other abuse.
- Routine engine tune-ups or adjustments.
- Engine or engine component failure (for example, combustion chamber, valves, valve seats, or guides) due to inferior fuel, wrong oils, or incorrect fuel/oil mixtures.
- Service parts not replaced according to the maintenance schedule.
